One Hundred and Eighty-Five (185) New Cases of COVID-19 in Plainfield

November 30, 2020

Dear Friends and Neighbors,

Since our last update on Wednesday, November 25, there are one hundred and eighty-five (185) new COVID-19 cases to report. An additional five hundred and twenty-eight (528) persons have been quarantined. No deaths have been reported since November 15, 2020.

Between **March 16, 2020 to September 30, 2020** there were two thousand, four hundred and sixty-five (2465) positive cases. **Since October 1, 2020**, there have been nine hundred and thirty-two (932) positive COVID-19 cases, two thousand, seven hundred and thirty-nine (2739) persons placed in quarantine, and five (5) COVID-19 related fatalities.

*Total overall number of positive COVID-19 cases since March 16, 2020: **Three thousand, three hundred and ninety-seven (3397)***

*Total overall number of persons placed in quarantine since March 16, 2020: **Eight thousand, three hundred and sixty-two (8362)***

*Total overall number of fatalities since March 16, 2020: **One hundred and eighteen (118)***

Governor Phil Murphy recently lowered the limits on indoor and outdoor gatherings due to rising COVID-19 cases across the state. The **indoor gathering limit is now 10 persons**, and **outdoor gatherings are now limited to 150 persons**. Please keep this in mind during the upcoming holidays.

Cases in our city are continuing to rise. I encourage you to get tested for COVID-19 if you are experiencing cold and flu symptoms that overlap with COVID-19 symptoms. Extreme caution will get us safely through the fall and winter season along with continuing to wear your face masks, limiting indoor gatherings and practicing social distancing while in public.

In partnership with Union County, the City of Plainfield will provide residents with free flu shots. The next date to get your flu shot is **Friday, December 4, from 9:00 AM-2:00 PM** at the Gerald B. Green Building, 200 West 2nd Street. Free COVID-19 testing at Kean University is now operating on an extended schedule to accommodate Union County residents. Testing is on Mondays, Wednesdays, and Fridays from 9:00 AM to 4:00 PM, and Thursdays from 9:00 AM to 2:30 PM. The test will also provide results for Influenza A and B (flu). **Insurance is not required.**
